(EMOLUMENTS) ACT**

(Act 16 of 1991)

**IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE
MINISTERS, MEMBERS OF THE NATIONAL ASSEMBLY AND SPECIAL OFFICES
(EMOLUMENTS) ACT, I MAKE THE FOLLOWING ORDER:**

Citation and
commencement.

1. This Order, which amends the Schedule to the Ministers, Members of the National Assembly and Special Offices (Emoluments) Act, may be cited as the Ministers, Members of the National Assembly and Special Offices (Emoluments) Order 2015 and shall be deemed to have come into operation on 1st July 2015.

Amendment of
Schedule to
Principal Act.

2. Paragraph (1) of the Schedule to the Principal Act, except the proviso, is amended by the substitution therefor of the following paragraph as paragraph (1), except the proviso –

“1. The persons holding the respective offices specified hereunder shall be paid salaries at the respective rates specified hereunder in respect of the said offices –

Prime Minister	\$20,580,000 per annum
Every Vice- President (other than the Prime Minister)	\$11,135,064 per annum
Cabinet Minister	\$10,439,124 per annum
Junior Minister / Minister within a Ministry	\$8,346,492 per annum
Attorney General	Same as the Chancellor
Speaker of the National Assembly....	\$10,439,124 per annum

Leader of the Opposition	\$10,439,124 per annum
Parliamentary Secretary	\$3,753,984 per annum
Deputy Speaker	\$2,702,880 per annum
Chief Whip	\$2,682,360 per annum
Every other member of the National Assembly	\$2,402,532 per annum”

Insertion of
paragraph 1B in
the Schedule to
the Principal Act.

3. The Schedule to the Principal Act is amended by the insertion immediately after paragraph 1A of the following paragraph as paragraph 1B –

“1B. The Schedule shall be read with such modifications, adaptations and qualifications as may be necessary in view of the amendment made by clause 2.”
